**CONDITIONS OF CONTRACT TO EXHIBIT**

1. The Texas Ground Water Association acts for exhibitors and their representatives in the capacity of agent - not as principal. The Association assumes no liability for any act of omission or commission in connection with this agency. Exhibitor and their representatives hereby release the Texas Ground Water Association from all liabilities for loss or damage from any cause whatsoever.
2. Subletting space is not permissible, except with the written permission of the Association.
3. If cancellation is made prior to December 31, 2023, refunds will **ONLY** be made, if space can be resold.
4. Exhibits should not project beyond space allocated and in no way, should they obstruct the view of, or interfere with the traffic to the other exhibits. In addition, no light or sound should be used which would cause objection from another exhibitor. The Association reserves the right to remove such objectionable fixtures.
5. All materials used in the exhibit hall shall be fireproofed and conform to all fire department regulations.
6. Helium balloons and adhesive backed decals will not be used or given away in the Embassy Suites By Hilton San Marcos Hotel Convention Center and Spa.
7. Automobiles, trucks, tractors, machinery, and other motor vehicles utilizing flammable fuels, which are placed on display, shall have no more than ¼ of the tank's capacity. Tanks shall be locked or effectively sealed, and battery cables shall be disconnected from the ignition system. Ignition keys for vehicles on display shall be kept by a responsible person at the display location. Mats must be placed under all wheels. No tire protectant cleaner shall be applied inside the Embassy Suites By Hilton San Marcos Hotel Convention Center and Spa. **All vehicles entering the building will be required to have their vehicle spaces protected with Visqueen prior to entering the facility and at the Exhibitor's expense.**
8. Exhibitor assumes entire responsibility and hereby agrees to protect, indemnify, defend and save the Texas Ground Water Association and its employees and agents harmless against all claims, losses and damages to persons or property, governmental charges or fines and attorney's fees arising out of or caused by exhibitor's installation, removal, maintenance, occupancy or use of the exhibition premises or part thereof.
9. Exhibitor acknowledges that the Texas Ground Water Association does not maintain insurance covering Exhibitor's property and that it is the sole responsibility of Exhibitor to obtain business interruption and property damage insurance covering such losses by Exhibitor.
